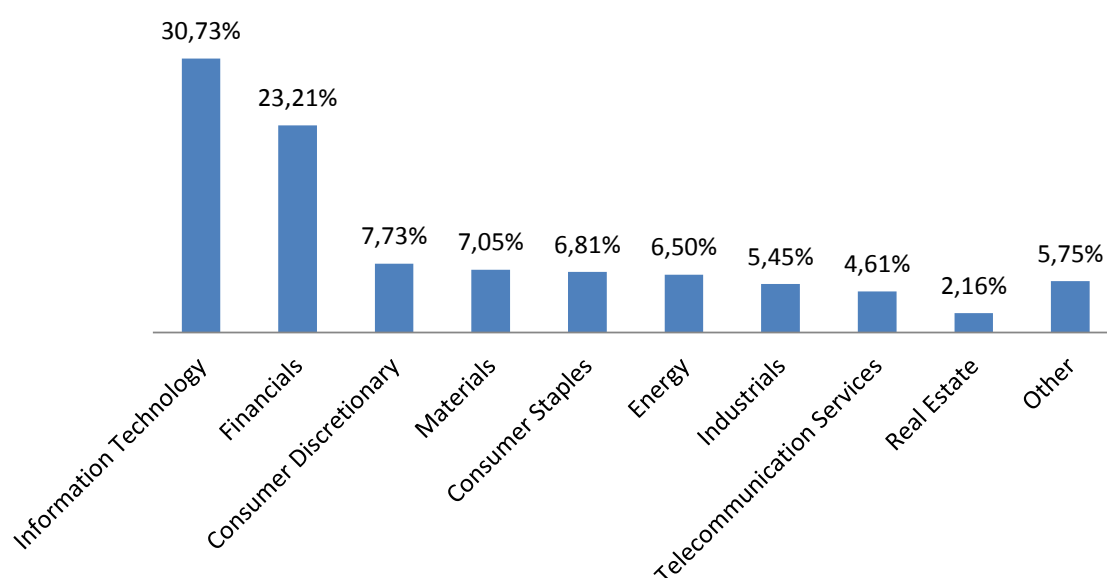

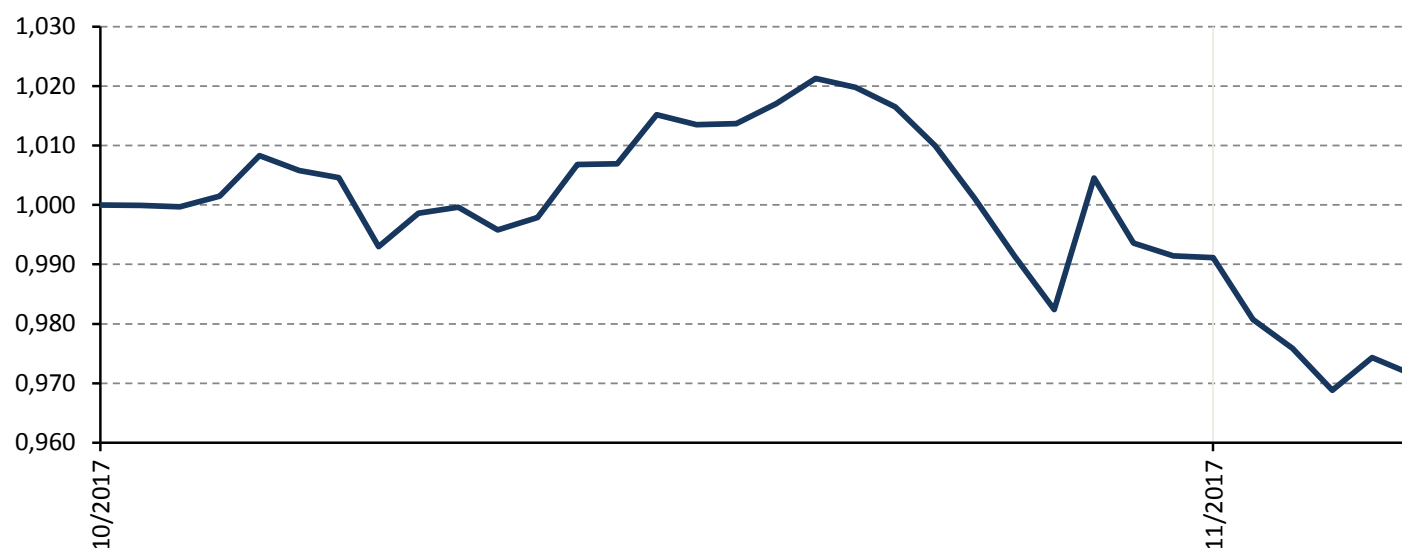
## Investment policy

Raiffeisen fond evropských akcií represents a 'feeder fund' to the Raiffeisen-EmergingMarkts-Aktien fund which – in compliance with its investment strategy – has been striving to generate long-term capital growths. The Fund invests at least 85 percent of its assets in securities issued by its 'master fund', Raiffeisen-EmergingMarkts-Aktien. Any remaining balance funds have been invested either in liquid assets or by way of hedging. The performance of the Feeder Fund has been measured in CZK. Any potential differences in the performances of the Feeder Fund and the Master Fund may have resulted from currency hedging applied in respect of the CZK/EUR exchange rate in the portfolio of the Feeder Fund.

The Master Fund, Raiffeisen-Europa-Aktien fund, invests at least 51 percent of its funds in equity and similar securities issued by companies with residence or operating in Asia, Latin America, Africa, Europe, and the Middle East. The Master Fund may also invest in bonds issued by either sovereign or supranational issuers, as well as in units issued by other investment funds.

Recommendation: The Fund may not be suitable for investors who intend to recover their invested funds within a term shorter than 10 years.
