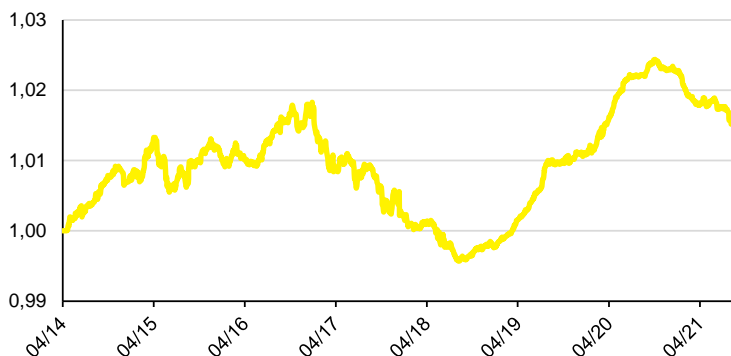


RAIFFEISEN FOND DLUHOPISOVÉ STABILITY

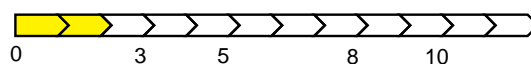

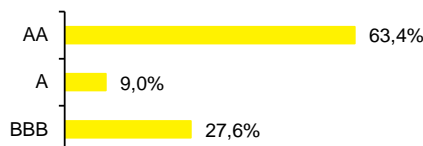
Risk profile (SRRI)



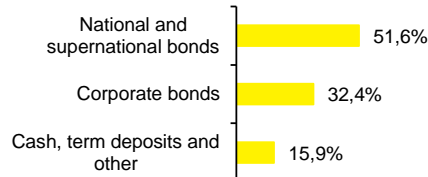
Recommended investment horizon
